CHANGES TO BY LAWS

1. The following sections will have email notification added:

- Article IV, #1: The Secretary shall cause to be mailed or emailed to every member.....
- Article IV #2: The Secretary shall cause a notice of such meeting to be mailed or emailed to all members.....
- Article V #8 b :shall cause the names of such candidates with the offices for which they are nominated, to be mailed or emailed to each member.....
- Article XIII : Notice of the proposed amendments to the by-laws shall be provided by mail or email to all members.....

2. Make the following changes in Articles:

- Article V : Officers
- Article VI : Duties of Officers
- Article VII : Board of Directors

Article VIII : Powers and Duties of the Board of Directors

3. Article IX, #2 : change: The Ice Show Chair must attend regularly schedule board meetings and will prepare a full written report of the procedures and outcomes of the show.

Article IX #5 : change: Basic skills Chair: The chair shall keep records of the Basic Skills tests passed by skating members, obtain USFSA Basic test badges and supervise distribution. The chair must attend regularly scheduled board meetings.

4. Article VII (changed from Article V – Board of Directors), #2 : The Board shall be comprised of 9 qualifying elected directors. In addition the President will appoint the Ice Show chair and Basic Skills chair to the Board on an annual basis unless the position is held by an already seated board member.

5. Article VII (above) #12: change to : The officers shall comprise the executive committee.

6. Article VII (above) # 6 (resignation or inability to serve) : add: The board is under no obligation to fill a Director vacancy from the slate of candidates put forth on any ballot.
